FAQ

The catalogue – an open electronic database of the Puli breed. The following data can be entered on each dog: photos, origin, judges' descriptions, exhibition results, health tests, titles, behaviour tests, contact details, etc.

To find a pull in the database - enter part of the pull's name in the search box and press Enter or click on the word "Search". The search works in the language of the dog's country of origin and in English. At the same time, you should keep in mind that due to the specifics of the spelling or translation, there can be inaccuracies in the spelling of the dog's names. This is especially true for countries where dog names in pedigrees are stated in national languages. In order to check the presence of the pull you are interested in in the database, we recommend writing fragments of the name in the search bar, which cannot be misspelt. To set more complex search parameters select the "Advanced Search" option. The result of the search will be a list of Pulis from the database that meets the selection criteria.

By clicking on the puli's name, you can go to the Puli's page.

The Puli's page - you can see a menu of extended information about the puli (located at the top of the page, under the dog's name):

- Relatives information about the relatives of the dog, contained in the database and the degree of kinship.
- Descendants information about the descendants of the dog, sorted by litter.
- Selection of mating parents a predicted pedigree of a descendant after mating with a selected partner, with an indication of inbreeding.
- Pedigree detailed pedigree with a given number of branches and a degree of inbreeding calculation.
- Information about the results of the dog's participation in exhibitions (information is limited to the data on exhibitions contained in the database).

The Puli owner can change and supplement the data about their dog. The changed data will be displayed only after verification by the administrators.

The Puli page provides the ability to upload photos and copies of documents. Only .jpg and .pdf files are accepted by the platform.

The publishing (addition) of information about a puli.

Before adding a puli – make sure that it is not already in the database. Any registered user can add dogs to the database. In order to check the presence of the puli you are interested in in the database, we recommend writing fragments of the name in the search bar, which cannot be misspelt.

Only the puli owner, who is a registered user and who has confirmed his ownership of the puli with documents, can change and supplement the data about their dog.

To protect against spam and harmful activity, all entries added to the catalogue are verified by an administrator. The information posted by you will not be visible until approved by the database administration. Verification and confirmation of the data may take 2-3 days.

Please note that information about the dog (tests, titles) is published only if you have uploaded the supporting documents in the allowed format on the dog page.

Contact details (address, phone numbers, email address) are added at the discretion of the owners.

If you find an error, an inaccuracy in the description of your puli, or just want to supplement the information, please contact the database administration.

The Kennels - the section offers information about existing domestic kennels and breeders engaged in breeding work within the framework of the RKF – FCI system. In this section, you can also see foreign kennels that have been previously or are currently working with the Puli breed.

To kennel owners - in this catalogue we place information about kennels that breed Puli dogs. In order for your kennel to appear in the catalogue, you need to upload a document of registration of the kennel in the RKF - FCI system. If you find an error, inaccuracy in the description of your kennel, or just want to supplement the information, please contact the site administration.

Exhibition - the section is created to speed up the addition of information about the results of exhibitions. The results are entered by administrators according to the reports of the hosts of the exhibitions. The Exhibition List section allows the user to sort exhibitions by year, country of hosting, exhibition status and expert. Information about the exhibition may be accompanied by photographs of the dogs participating in the exhibition. If you have such photos, please send them with appropriate explanations to the site administration. If you find an error in the exhibition data, please inform the site administration.

Judges – here you will find information about the experts who carry out examinations of Puli breed.

Offered for stud – Put the appropriate mark in the puli card will make the dog automatically get added to this section. You can view all the puli offered in this section through an advanced search by marking the field "for stud".

For sale - you can put the appropriate mark in the puli card, and the dog automatically gets into this section. You can view all the puli offered in this section through an advanced search by marking the field "for sale".

The main page will display random dogs.

INFORMATION. SOURCES, DATA USAGE AND PUBLISHING.

- 1. **Sources of information.** Only dogs which have certification documents of being of the Puli breed are entered into the database. Information enters into the database the following ways:
 - from the owners;
 - from the archives of organisations;
 - from the exhibition catalogues of the RKF / FCI;
 - from catalogues, books, magazines, files, photo collections, breeding books created / published before the 1990s.

Data on dogs whose owners and breeders are no longer engaged in the breed can be entered into the database in order to preserve as much information about the history of the breed as possible.

2. **Publishing of information.** Information is entered as soon as it gets provided. Administrators enter data as quickly as their schedule allows. Administrators respond to all emails.

- 3. **Changes in information.** When processing information, any objections and comments from respondents, owners and visitors are accepted. Conflicts are resolved on an individual basis. Administrators reserve the right to correct obvious errors and mistakes.
- 4. **Use of information.** The official database of the Puli breed is an electronic resource with open access and is hosted on the Internet. The text and photos are available to users in accordance with the laws of the Russian Federation. The Database information can be freely used for any non-commercial purposes. Commercial use must necessarily be agreed with the RPC.
- 5. The policy of the Administrators of the Database regarding the publishing of contact data. The name of the owner of an individual dog (breeder) is automatically added from the pedigree (catalogue) as information available from open sources. The name of the kennel/factory prefix is automatically added by the administrators to the category "Kennels" together with the first added dog from this "Kennel". Therefore, the editors, first of all, indicate the name, city of residence and website (if available). The entering of a "Kennel" on the initiative of the owner requires a copy of the certificate of registration of the kennel / kennel name, as well as a copy of the certificate of assignment of the kennel brand (if any).
